

Sample Letter Templates for David Rabbitt for Supervisor:

1. Getting to and from home to work, school, church, shopping, etc. is a universal task for everyone who lives in Sonoma County. Whether you are driving to buy goods, or simply having items delivered to your home, you are impacted by the roads and your cost of goods are impacted by our roads. Since David has been in office, the dollar amount of money spent on our roads to make them smoother, safer, and therefore make our goods less expensive, has been increased 10-fold.
