Advocacy-An Example of How it Works for ECA Members



As we move into a new year and ECA member firms are being asked to renew their memberships, it might be a good time to remind folks that the ECA does a lot more than just put on great events and honor accomplishments of individuals and companies. Advocacy is part of what the ECA does and in my opinion, advocacy is reason enough for firms that are in the general contracting sphere of influence to belong to and support the ECA.

I want to be very clear-I am not taking credit for correcting a wrong by virtue of advocating for that correction. This Soapbox is intended to illustrate advocacy, to be effective, must be constant, dependable, and focused. Advocacy also needs collaboration, relationships, professionalism, and staying power.

What am I talking about?

About 18 months ago, I got a call from a member that told me about some flood plain mapping that was being done by FEMA. FEMA routinely updates their flood plain maps all over the country every decade or so, supposedly using the latest flood data as well as any flood control projects that might improve an area's ability to gather and dispose of flood waters. The call came in and informed me that the FEMA updated maps were utilizing erroneous elevations, and FEMA was not incorporating storm drain improvements that were put in place by my old firm, Kirkwood Bly under the supervision of Dave Soiland (back in the day!).

Bill Olmo and Dan Fowler asked me to assist. What FEMA was doing was they were about to issue flood plain mapping that would identify a lot of parcels around Santa Rosa Avenue to be "in the flood channel" and thereby those properties could not legally have structures built, nor even store materials on their land as the mapping would categorize those properties as being in "flowing channels" during high rain events.

What this would mean to those properties is:

- 1. Their value would drop tremendously
- 2. Those properties would not be able to be used as the purchasers and owners of those properties had planned to use them
- 3. Sonoma County property tax revenues could drop year after year due to the lower assessment value of those properties
- 4. Insurance would be hard to procure or impossible to afford for those newly labeled properties.

I suggested to Bill and Dan that I inform our friends at the Sonoma Business and Agriculture Consortium, and that we reach out to the City of Santa Rosa Mayor, as well as the Permit and Resource Department head Tennis Wick and his deputy Nathan Quarles for information and assistance. Bill and Dan agreed, and the process of advocacy began.

I found out quickly that Cynthia Murray and the NorthBay Leadership Council was willing to use their advocacy influence with Congressman Mike Thompson and letters were written and received. Pressure on FEMA to reassess their mapping "facts" was started at the National level.

I reached out to a neighbor of mine who was very high up in FEMA until he retired two years ago and got information as to how FEMA might be influenced.

I asked Mayor Rogers of Santa Rosa what the city would be willing to do and got a response that said they were not legally allowed to influence the FEMA mapping efforts, but the County could.

I reached out to Nathan Quarles and requested an onsite meeting with Dan and Bill to look at the more obvious errors that FEMA was using. After that meeting, the County (and prior to that onsite meeting they had written some letters as well) exerted some influence on FEMA using legal channels.

I reached out to State Senator McGuire's office and got advice on how to exert influence on FEMA as well.

I reached out to County Supervisors Rabbitt and Hopkins and kept them informed of the situation and requested they support PRMD in their efforts to influence FEMA and correct the mapping data.

Dan and Bill (with Nathan Quarles) got the regional FEMA official to come out onsite and witness the same elevation benchmark information (using levels and transits) that was demonstrated to Nathan Quarles and got an admission from FEMA that their data could be wrong.

A "stay" was issued. And now for the acknowledgements and compliments that our public officials do not receive very often:

Kudos to the County of Sonoma and to Nathan Quarles for their efforts. The correction is not a guarantee and FEMA is not easy to influence. But the County has started the process of "re-mapping" the area at considerable expense to the County of Sonoma. The "kick-off" was last week, and the work should be done in approximately 90 days. At that point, the re-study will be presented to the County and the County intends to attach that professional, independent, study to a Letter of Map Revision application to FEMA. The County anticipates the area south of Hunter Lane, east of Santa Rosa Avenue, and north of the Wilfred flood channel will be remapped out of the flood plain designation FEMA has it currently under. There are other areas of concern but those are the main areas that should be changed.

This effort is not done yet but is a shining example of how advocacy can work. You might be asking yourself how does this benefit other ECA members? The benefit comes from not seeing the property tax assessments go down in the County of Sonoma. Part of those property tax dollars collected goes towards services that directly benefit all ECA members and part of it goes towards maintenance and capital improvement projects that ECA members bid on.

Many thanks to Bill Olmo and Dan Fowler for their perseverance and determination in trying to correct the wrong. The ECA is very happy to have done our small part to assist the effort!





I have received several inquiries into prevailing wage designation for trucking on haul and off haul for public works projects lately. We are trying to schedule a seminar with Smith Dollar and the Department of Industrial Relations (State of California) to clear up issues pertaining to recent clarifications and confusion regarding trucking prevailing wage. Until we do, here is some very recent news on hauling materials onto a public works site for you:

January 4, 2023

As we roll into 2023, we continue to receive questions on what, if any, impact AB 1851 has on the industry and day-to-day operations. The detailed explanation below serves as a primer of what happened and what, if anything, your company needs to do.

The Basics: What Happened?

Effective January 1, 2023, <u>AB 1851</u> codifies into law a longstanding enforcement interpretation from O.G. Sansone v. DOT (1976) and Williams v. SnSands Corp. (2007) that prevailing wage coverage applies to "the on hauling of materials used for paving, grading, and fill onto a public works site, if the individual driver's work is integrated into the flow process of construction."

Simply put, AB 1851 imported the longstanding interpretation of prevailing wage hauling coverage into Labor Code. Therefore, AB 1851 actually maintains the status quo for prevailing wage hauling coverage on public works. Clearing Up the Confusion

One area of confusion for some is that in August 2021, Sansone was actually overturned by the California Supreme Court under Mendoza et al v. Fonseca McElroy Grinding Co.et al. However, the DIR and awarding bodies never issued any new guidance, and most contractors did not change their business practices.

Another area of confusion stems from the claim that, under AB 1851, prevailing wage coverage does not apply if the truck driver does not exit their vehicle during delivery. However, it is not advised to operate under that interpretation since it is not corroborated by the law, legislative history, or any interpretation from the DIR or other enforcement agencies. ~ continue on page 8


The foundation of the ECA has been to address local needs and issues.
