## **Regulations Require Maintenance**

Requirements are getting more and more expensive and complex to build in Northern California. This last week I met with Nathan Quarles from Sonoma County and Gabe Osborn from City of Santa Rosa on issues pertaining to getting a project going that needs grading, encroachment, Fire and building permits.

It isn't getting easier.

When rules are established, there are usually good reasons to establish regulations initially. Once regulations are in place, they become impediments to construction in ways the original drafters of the regulation never envisioned. The result of these regulations is that goals to build more housing, or to zone an area for commercial development, or even a goal to make our roads better, become way more complex and expensive. The end result is the improvements either are not done (too risky or too expensive), or that developers and planners need ever increasing piles of money to accommodate these regulations.

I know- this is an old issue. But some of these well intentioned regulations are hard to get rid of.

At The Construction Coalition meeting held Thursday, we discussed complex issues facing our housing industry moving forward on much needed projects.

Some regulations and issues we discussed that have become obstacles to construction:

- A).CEQA. Initially created to protect the public from pollution from public projects, it has now become a "weapon" to stall or deny projects if they increase "vehicle miles travelled".
- B. Hillside Ordinance. Initially created to protect public from impacts from building on steeper hillsides that could fail and affect downhill folks, it is now an expensive design/construction item that is broadly applied to planter areas and other low risk parts of a project.
- C. The 50 yard "trigger" that necessitates a grading permit. There is nothing that modifies this requirement that has to do with the size of the project. Seems ridiculous that a landowner wanting to rerock his long driveway needs a grading permit right?

Some of the benefit of participating in an ECA or other association that influences these regs, is obvious. Just trying to understand them on your own is difficult. The ECA will continue to dialog with groups and agencies that administer these regulations and make you all better businesses because of those continuing efforts!

Where these regulations lend themselves to a "fix", the ECA will be at the table pushing for that fix.

2. **Specification Committee**-co chairs Dale Smith of RCX and Casey Wood of Ghilotti Brothers In. Meeting held 7-19-23 Meeting Notes:

Subjects-Grading Permits, Encroachment Permits, Fire Line Permits-entitlement process takes a long time -what can we do to shorten process?

County has different issues than SR. County gets application, it is checked for completeness by a technician, then distributed to primary and secondary review departments (like Fire, Sewer, Grading, etc.). Review by departments create Comments and application is held until all departments respond before resubmittal can occur. This is time consuming and can lead to confusion as various reviewers may not submit complete list of comments after initial review. Applicant can get application back and might think comments are complete, resubmit accordingly, and more complete application then gets more complete comments. Process could repeat several times.

Logical fix? Allow conditional approval on "up front" items so construction process can begin and resubmit on application areas that need more or corrected info. Problem? County feels confusion and loss of control could occur.

SR issues are primarily due to prioritization. Example is a complex affordable housing application comes in at same time as a "one off" commercial project. Due to staffing issues, the "one off" project could be pushed aside for a while.

Logical fix? Not many options as bigger project will get priority. City of SR does have core belief to do creative approvals to keep the project construction going.

3. **Nominating Committee**-chair Walt Turner of North Bay Petroleum. Meeting was held 7-17-23, attendees Mike Gulley of NWGEN, Tony Mencarini of GCC, Kimber Carpenter Lenning of Kadon Trucking, Dan Giordano of Argonaut, Dave Weller of RCX, John Bly of ECA.

Committee went over past applicants and added more to be considered for Contractor of the Year, Affiliate of the Year, Volunteer of the Year, Hall of Fame both living and posthumous, Golden Hardhat, and Bridge Award. On all but Bridge Award, Committee refined choices to no more than three candidates to be decided at August Committee meeting and presented to Board of Directors at September 19 Director meeting. Committee came prepared, candidates were vetted, and there was good participation and energy. Although I had asked for suggestions from the Board and ECA membership, I received no suggestions, so all candidates were proposed by the committee. No real problem with that at all. Good choices were made in my opinion.


#### NEWS YOU CAN USE:

1. County of Sonoma passed Project Labor Agreement on 7-18-23. Waiting for written document and I will post when I can. I did watch the Supe meeting video (you can access the link <u>here</u>), and the material suppliers and trucking were excluded from the PLA with project limit going from \$10 mil to \$1 mil. Special thanks to Wendell Trappe and Jeff Rhoades from Canyon Rock and Kimber Carpenter Lenning from Kadon Trucking who took time to attend and speak. Kudos to Lisa Schaffner of NCBE for speaking on behalf of Construction Corps and CTE.

2. City of Santa Rosa PLA will now be in effect for public works projects going to bid after July 1, 2023. The written document will be sent to me before the end of July and I will distribute it. Unlike the County of Sonoma, the City of SR does have suppliers and trucking included in their PLA and we are already hearing some trucking firms are being required to have truck drivers pay the union benefits if they are bidding. The Board asked me to have Smith Dollar do a workshop on how to deal with bidding on City of SR projects as soon as possible. Look for the announcement as soon as the PLA document arrives!

3. Lots of work in Santa Rosa to bid right now, and more coming! County has one more big paving project coming soon as well.
