Rules and Regulations Governing Vendors

PAYMENT—a non-refundable payment is required at the time the contract is accepted. Vendor also will not sublet or assign any vendor space without written consent from the car show management. A contracted vendor is not allowed to share a vendor space with any other vendor or business. Vendors who ignore this provision will be charged another full price vendor charge. There will be no refunds issued, even for no shows or weather conditions.

INDEMNIFICATION: Vendor agrees to indemnify and hold harmless the car show, ECA & their management, employees, City of Santa Rosa, members and guests from any and all claims, any action or suit resulting from any loss or injury to persons to whom the vendor may be liable including, but not limited to, Worker's Compensation Law. Vendor also agrees to hold harmless ECA, City of Santa Rosa, volunteers and employees from any loss of property or merchandise caused by vendor's appearance in the show. Vendor is also responsible for any loss of equipment or space material resulting from misplacement or theft.

INSURANCE: Vendors wishing to have insurance on their booth must do so at their own expense. ECA or City of Santa Rosa will not be held responsible for the safety of exhibits from fire, robbery, accident or any injury to vendors or their employees at the event.

EXHIBIT SPACE: Vendors must be in the park and set up by 6:45 am. Enter off of South A Street
Vendors must remain in place until after the cars leave—Show hours—9 am—4 pm
Vendors are responsible for providing their own power/energy needs & set up.
All vendors MUST be out of the park by 5 pm.

PERMITS: Food Vendors are responsible for providing:
Temporary Food Facility Permit issued by the Sonoma County Health Services and expiration date.
Copy of State Board of Equalization Sellers Permit
Santa Rosa Business Tax Certificate.
Propane use permit if using propane.
