Committee Oversight Behind the Scenes

The ECA does quite a bit of good work "behind the scenes". I think it is good to remind our ECA family what the ECA does for the benefit of Sonoma County residents as well as the environment by virtue of some of our committee work that might not be well known to many of you.

As an example, I want to specially talk about the Sonoma County Transportation Authority Citizen Advisory Committee (CAC) that I am honored to be the Chair of. Mark Soiland is one of the Committee members, as is Brian Ling (former Alliance Executive Director).

What the CAC does is meet at least once a month to review and approve the Measure M tax revenues and the spending of those dollars. With the passing of the Go Sonoma Act (a 1.4% sales tax measure beginning in April of 2025 for 20 years), the CAC will also be reviewing and approving the income and expenditure of those sales tax dollars as well as the expiring 20-year tax Measure M which started in 2004 and "sunsets" in March of 2025.

Other grant dollars are taken in by the Sonoma County Transportation Authority (SCTA), and those dollars are also reviewed by the CAC to ensure the dollars are being collected and spent in accordance with the sales tax measures passed by the voters in Sonoma County in 2004.

The CAC also oversees the various municipalities that receive funding from the SCTA like the Local Bus Transit Authority, all nine cities in Sonoma County, the Sonoma County Transportation and Public Works, some SMART train oversight, and various bicycle pedestrian pathway projects, as well as the Regional Climate Protection Authority of Sonoma County.

The dollars we are talking about run around \$32 million per year in sales tax revenue and those dollars are split as follows:

- ♦ 40% for Highway 101 projects
- ♦ 20% Local Street Projects
- ♦ 4% Bike/Ped Projects
- ♦ 5% SMART passenger rail
- ♦ 20% Local Road Rehabilitation
- ♦ 10% Local Bus Transit
- ♦ 1% Administration

Every month, the CAC meets in person and reviews the efforts of the various groups that receive the funds each month. There are rules and reviews that go into whether a project will receive funding from Measure M. As an example, the City of Santa Rosa must submit a list of projects that they want to be eligible for funding each year. The CAC reviews how the City of Santa Rosa performed and executed the submission process as well as how many dollars the City of Santa Rosa is putting forth to fund the project being considered. The process is complex and the CAC reviews and probes the SCTA staff on each and every criteria.

It should be noted that one of the criteria that is VERY important to many of the CAC committee members, is to not expand the use of carbon fueled vehicle usage. The focus on "vehicle miles travelled" is real, and projects that simply expand the road width will probably not get approved in the process. It is a constant debate that occurs every month and ECA members should thank the leadership of Mark Soiland, Brian Ling, John Bly and a few others that take a holistic view of projects rather than a strict view of saying "no" if the project will result in additional vehicle miles travelled.

As an example, the Hearn Avenue overpass (over Highway 101) has been considered, and designed, and "tweaked" for many years. Some CAC members did not want it built at all as it will reduce waiting times on Santa Rosa Avenue and Hearn Avenue and they believe that will increase GHG emission into the atmosphere. Some of us debate that cars idling and waiting to cross Highway 101 add more GHG emissions due to their idling in place than the increased flow of traffic over the Highway 101. After several years, the project is now being constructed.

I will give you one example of a perspective by one of the Committee members: Last month, one member stated we (the CAC) should not be approving projects that make it more "attractive" to drivers of cars. This committee member was supporting the concept of allowing roads to get rougher and degraded so people would be forced to ride bikes or walk more.

I pointed out that goods are delivered in transport vehicles and there is a safety issue to smoother roads where bikes and cars do not hit bad spots and lose control. I also pointed out the voters voted in these tax measures and what to spend the tax dollars on and it was not the committee's job to change the will of the voters.

Whether you are a member of the ECA or not, this is the kind of work the ECA is doing to make sure our roads and bikes and pedestrian paths are built and maintained to support ALL of the community while keeping an eye on the environment.

I am proud to Chair this Committee, and very proud of the work we do. Recently, the financial audit came back from a CPA firm and the audit found zero discrepancies in sales tax income and outgo. By the way, the sales tax projections made in 2004 have proven to be 97% accurate nearly 20 years later. That is due to good staff at the SCTA and good leadership and oversight by the CAC and the Board of Trustees for the SCTA.

COMMITTEE NEWS


ECA Government Affairs Committee- led by Art Deicke, will continue to influence local elections.
