### We Have Become the Ostriches

The lack of actual economic planning for cities is becoming more evident every day. It seems like the news is full of one city after another claiming they have a budget crisis they did not foresee.

Cities have long depended upon simply passing a sales tax measure to make up for a lack of good, sound economic development policy.

Now that municipal income has been pinched because of some businesses that have left the area via retirement/excessive regulations/change in business climate/other reasons, some that have not survived the pandemic turndown, and the coming to terms with higher and higher payroll costs as well as benefits given to city employees over the decades, the time has come to have a reality check!

Santa Rosa has been (at least for a few months now) wrestling with a looming shortfall in their budget that has come into focus recently. Santa Rosa will be making some substantial cuts in services and up to a 10% reduction in city employees soon because they cannot possibly raise enough new tax revenue to bail themselves out of the crisis they now realize.

Tuesday, 8-6-24 the SR Council voted to send a tourist tax and business license tax to the voters to make their budget deficit reduce by \$4.6 million per year. That is not enough to make up for the budgeted shortfall, so cuts will be coming to services provided by SR. They have to cut. ## With all of the forecasting brainpower these cities have access to, shouldn't they have known the looming budget crisis sooner?



### **Workplace Violence Program**

Implementation "Target Date" - July 1, 2024

Senate Bill 553 requires employers to create, implement and maintain a Workplace Violence Program by July 1, 2024. Employers must also train their entire workforce.

The Workplace Violence Program must include a reporting mechanism (how is the employee going to report incidents), detailing who will be responsible for receiving complaints, and who will be responsible for identifying and mitigating workplace hazards.

Jim Persons has developed a Workplace Violence Program and Active Shooter Guidelines that meet the requirements of this new regulation. He can also provide training resources for your employees.

### **CALIFORNIA'S NEW WORKPLACE VIOLENCE PREVENTION REQUIREMENTS**

No later than July 1, 2024, covered California employers must implement extensive workplace violence prevention plans (WVPP) and deliver specified training to employees under new legislation signed by Governor Gavin Newsom on September 30, 2023. In order to comply on time – including preparing plans that are "specific to the hazards and corrective measures <u>for each work area</u>" as required – employers will need to prepare early.

Senate Bill 533 adds section 6401.9 to the California Labor Code. The legislation is intended to help employers prevent and respond effectively to workplace violence.

Covered employers must deliver the training to all employees no later than July 1, 2024, and annually thereafter.
