I am always amazed at NIMBYs who don't want quarries, concrete ready mix plants, or asphalt plants near where they live although they do not seem to mind if more truck traffic is needed because of their opposition to local production of the needed products for bike paths, road repairs, bridge construction, etc.

I recall when there was a huge environmental protest of getting aggregates out of the Russian River some 40 years ago. The shift was made to go to hard rock mining of aggregates, and no more river rock was removed. Part of the argument back then was that "we should bring the aggregates in from British Columbia and Mexico" and stay out of hard rock mining as well as Syar's river aggregate removal. No legitimate thought seemed to be given to how the aggregates were mined in foreign countries, how much damage to the environment would occur from barging the rock for thousands of miles in the ocean, and what environmental controls/worker compensation/safety protocol policies would be experienced in a foreign country vs us taking care of our own needs for rock, concrete and asphalt with local sources that could be controlled and monitored.

Ideological virtue noise. That is how I saw most of the arguments back then. When folks spoke passionately about environmental damage from taking aggregates out of the Russian River, they never acknowledged the wet weather flows that, in one season, could move gravel bars 20-25' deep, from one side of the river to the other. There were many instances where bridge abutments were washed out, farmers and ranchers would lose hundreds of acres of prime land to erosion from the river channel being moved toward a bank that then collapsed into the river flow. Tremendous good could have come from removing gravel from the Russian River and it could have been done without getting into the river flow at all.

But I digress. That ship has sailed. Quarries got out of the river and went to hard rock mining on land.

When Dutra wanted to build their asphalt plant at Haystack Landing in Petaluma, I went to several town hall meetings where people would get up and talk about how much cancer would increase from the vile poison the plant would put into the streams and air. Although there was zero factual basis for fear mongering, boy was it effective. As we all know, the plant was not built at Haystack Landing.

BoDean has had their share of neighborhood "hand wringing" over the years from supposed fumes harming the neighborhood near their plant on Maxwell Court in Santa Rosa. They have been working on the entitlement process to move to an industrial area near where the old Standard Structures were in Windsor. Neighborhood outcry was early and often about how folks could never open their windows again if the plant would be built there.

Now Canyon is hearing the same outcry that Syar, Dutra, and BoDean have heard for decades. It doesn't matter that the rock, concrete, and asphalt need to be processed somewhere and delivered to the project site.

This course is required by OSHA before an employee can enter a Permit Required Confined Space. Certification of completion is provided.



#### EMERGENCY RESPONSE MANUAL ~ 2025—2026


















#### NORTH BAY CONSTRUCTION CORPS
