## **ECA COMMITTEE NEWS**

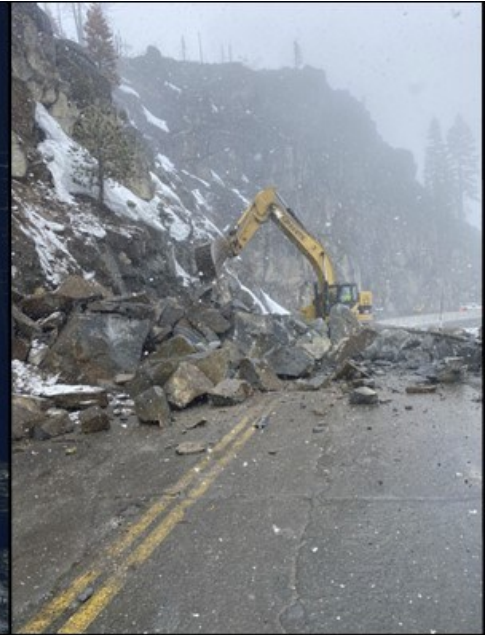

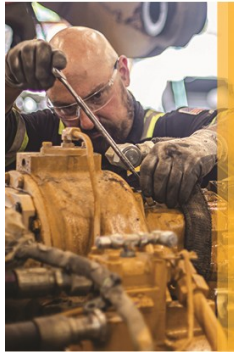
